



# New Mexico Absentee Voting

## Who can vote absentee

**Any registered voter may vote absentee. No excuse is required.**

## Ways to vote absentee

**You can vote by mail or in person before the general election on November 2, 2004.** Following are the instructions for both.

Absentee voting is managed by your local county clerk. We have provided their contact information at the end of this document.

## Vote by Mail

**To vote absentee by mail you must apply for a ballot with your local county clerk. You may apply for an absentee ballot anytime during the calendar year up until October 28, 2004.** We recommend that you apply for your ballot no later than October 15, 2004 to allow enough time to process your application.

### Instructions

- 1) Print the attached form.
- 2) Read the instructions accompanying the form.
- 3) Fill out the requested information on the form carefully.
- 4) Sign the form.
- 5) After filling out the information needed for your absentee ballot application, place page 2 inside page 1 and fold accordingly. TAPE all edges closed.
- 6) Mail it to your county clerk. A county clerk list is provided at the end of this document.

## Absentee in person voting

**Absentee in-person voting is held at the county clerk's office from October 16 through October 30, 2004.** In addition, certain counties also have satellite polling places open 17 days prior to an election. Contact your county clerk as to the location of these sites.

## **Voter responsibility**

The voter is solely responsible for complying with any and all election laws and voting requirements.

## INSTRUCTIONS - INSTRUCCIONES

1. Type or print your name, your STREET ADDRESS (no P.O. Boxes) and the last four digits of your Social Security number in the spaces provided. (A birth date may be substituted for the last four digits of your Social Security Number).

3. Sign and date your application.

4. Return your application in person or by mail to the County Clerk.
